Avivara supports several organizations in Guatemala and Nicaragua that work to improve the quality of and access to education and educational materials. Each of these non-governmental organizations are registered non-profit organizations in their respective countries.

These organizations include:

1. **ASOCIACION AVIVARA:** This organization is the primary partner organization of Avivara (U.S.) and is responsible for administering its educational programs in Guatemala. Asociacion Avivara maintains its accounting records on a cash basis and documents all receipts and disbursements related to its school improvement and scholarship programs. This documentation is submitted on a monthly basis to a licensed accounting firm in Antigua, Guatemala. This firm in turn submits audited financial reports to Guatemalan government entities and taxing authorities, as well as to the Executive Director of Avivara in the U.S. All documentation of receipts and disbursements are scanned and available for review and audit by the Avivara U.S. Board of Directors.

In 2017, Asociacion Avivara distributed 96.6% of its expenditures to programs, and 3.4% to administration. Included in program expenditures was funding for school improvements (i.e., teaching materials, textbooks, student school supplies, libraries, computer labs, health & nutrition programs, student government/leadership programs, and water system improvements.) These expenditures served approximately 10,800 students in 68 schools in the departments of Sacatepequez, Escuintla, and Chimaltenango. The second major area of expenditure was for scholarships for students to attend, junior high, high school and university. This program funded scholarships for 108 students in junior high and high school, and 21 students attending university.

2. **BECAS ESPECIALES USPANTAN:** This program distributed junior high, high school and university scholarships to 88 students living in or near Uspantan, Quiche, Guatemala.

3. **NUEVOS MAYAS SCHOOL:** This school is located in the village of Xix, Quiche, Guatemala and provides courses of study in college prep and technical skills. It serves 110 students. The funding from Avivara for this program goes primarily for funding scholarships to young women so that they can attend the school.

4. **LIBROS PARA NINOS:** This program is located in Managua, Nicaragua and has established reading centers in over 40 communities and publishes culturally and linguistically appropriate literature for young people in Central America. Avivara's support is only a small portion of their overall funding, which comes from a variety of international sources.
