Avivara supports multiple organizations in Guatemala and Nicaragua that work to improve the quality of, and access to, education and educational materials. Each of these organizations are registered non-profit, non-governmental organizations in their respective countries.

These organizations are:

1. Asociacion Avivara is the primary partner organization of Avivara (U.S.) and is responsible for administering the programs in Guatemala that rely on support from U.S. donors. Asociacion Avivara maintains its accounting records on a cash basis documenting distributions for school improvement grants, scholarships and other program expenses. It submits monthly financial reports with supporting documentation for all revenues and disbursements to a licensed accounting firm in Antigua. This firm in turns submits audited reports to the Guatemalan government and taxing authority on a quarterly and annual basis. In addition, scans are made and saved in multiple digital forms of all disbursements. These scanned documents are available for review by the Avivara U.S. Board of Directors and Treasurer.

In 2016, distributed 97% of it expenditures on programs, and 3% on administration. Included in these program expenditures were funding for teaching materials, student supplies, technology, infrastructure projects and reading improvement programs in a total of 58 schools serving over 9,800 students. It also distributed 110 scholarships to students attending junior high, high school and university (20 students.)

2. Becas Especiales Uspantan is a sponsored program of Avivara. In 2016, it provided scholarships to 82 junior high and high school students living in the area around Uspantan, Quiche, Guatemala. It provides Avivara with annual reports of these disbursements.

3. New Mayas School in Xix, Quiche provides scholarships to slightly over 100 students to attend the high school in Xix to learn academic and vocational skills.

4. Libros para Ninos is a registered NGO in Nicaragua. In 2016, Avivara sponsored their efforts to establish a development program for raising additional funds from donors in the United States.

5. SERES is a program dedicated to improving environmental awareness and leadership skills among young people in Guatemala and El Salvador. Since it established its own 501(c)(3) status in the U.S. in 2016, Avivara's sponsorship for their programs was discontinued early in the year.
